**Notice of Public Hearing Regarding Setting Self-Insurer Premium Calculation Rates and

On December 19, 2024, the Industrial Commission of Arizona will hold a Public Hearing pertaining to Setting Self-Insurer Premium Calculation Rates and Schedule of Deviation Rates Under A.A.C. Rules 20-5-1534 and 20-5-1535. The hearing will be held at 1:00 p.m. in the Commission's first-floor Auditorium located at 800 West Washington Street, Phoenix, Arizona. This hearing will be held as part of the Commission's scheduled meeting for that day.

Under A.A.C. Rules 20-5-1534 and 20-5-1535, after notice and a hearing, the Commission is authorized to set Self-Insurer Premium Calculation Rates and Schedule of Deviation Rates for calendar year 2025. In addition to public comments, the Commission will also consider a proposal prepared by Commission staff, which will be posted on the Commission's Accounting webpage <https://www.azica.gov/divisions/administration/accounting>. The Staff Proposal is a preliminary document intended to serve as a foundational document for discussions that may arise during the public hearing process.

The record is considered open, and written and oral comments will be accepted until the close of the hearing on December 19, 2024.
