<u>SERIOUS</u> – Citation 1 - Item 1 – A seatbelt installed on an orange telescopic forklift was not worn by an employee operating the equipment (1926.095(a)).

<u>SERIOUS</u> – Citation 1 - Item 2 – Three employees were elevated to a height of approximately 30' above ground level utilizing a shop made metal basket that was approximately 4'1"W, X 3'7-1/4" H, X 7' 2-5/8" L via an orange telescopic terrain forklift and the forklift was not designed for such use (1926.451(c)(2)(iv)).

<u>SERIOUS</u> – Citation 1 - Item 3 – Two employees did not maintain their feet on the platform of a shop fabricated metal basket that was approximately 4'1"W, X 3'7-1/4" H, X 7' 2-5/8" L that was raised approximately 30' above ground level via an orange telescopic terrain forklift, as one employee was sitting on the top rails of the basket and another employee was standing on the mid-rails of the basket (1926.451(g)(1)).

<u>SERIOUS</u> – Citation 1 - Item 4 – Three employees were working from a job fabricated basket that was approximately 4'1"W, X 3'7-1/4" H, X 7' 2-5/8" L that was raised via a telescopic forklift at approximately 30' above ground level and had not been provided with scaffold training in the procedures to minimize fall hazards (1926.454(a)).

<u>SERIOUS</u> – Citation 1 - Item 1 – The quantity of flammable and combustible materials kept in the vicinity of spray operations was in excess of the minimum required for operation and or one day or shift (1910.107(e)(2)).

<u>GROUPED SERIOUS</u> – Citation 1 - Item 2(a) – A written respiratory protection program that included the provisions in 1910.134(c)(1)(i)(ix) with worksite specific procedures was not established and implemented for required respirator use (1910.134(c)(1)).

Citation 1 - Item 2(b) - The employer did not provide a medical evaluation to determine the employee's ability to use a respirator, before the employee was fit tested or required to use the respirator in the workplace (19103134(e)(1)).

Citation 1 - Item 2(c) - The employer did not ensure that employee(s) required to use a tight-fitting face piece respirator passed the appropriate qualitative fit test (1910.134(f)(1)).

Citation 1 - Item 2(d) — The employer did not ensure that each employee could demonstrate knowledge of why the respirator was necessary and how improper fit, usage or maintenance could compromise the protective effect of the respirator (1910.134(k)(1)(i)).

Citation 1 - Item 2(e) — The employer did not provide the basic advisory information on respirators, as presented in Appendix D of this section, in written or oral format to employees who wear respirators when such use was not required by the employer (1910.134(k)(6)).

<u>GROUPED SERIOUS</u> – Citation 1 - Item 3(a) – Floor(s) of workroom(s) were not kept clean to the extent that the nature of the work allowed in that saw dust was not regularly removed from surfaces within the workplace (1910.141(a)(3)(i)).

Citation 1 - Item 3(b) - Employees were permitted to consume food or beverage in area(s) exposed to toxic materials (wood, dust) (1910.141(g)(2)).

<u>GROUPED SERIOUS</u> – Citation 1 - Item 4(a) – A horizontal edge sander was not provided with mechanical or electrical power controls so located that the operator could cut off the power from the machine without leaving his position at the point of operation (1910.213(b)(1)).

Citation 1 - Item 4(b) — Provisions were not made to prevent a horizontal edge sander from automatically restarting upon restoration of power after power failure (1910.213(b)(3)).

GROUPED SERIOUS – Citation 1 - Item 5(a) –A circular handfed ripsaw was not guarded by an automatically adjusting hood which completely enclosed that portion of the saw above the table and above the material being cut (1910.213(c)(1)).

Citation 1 - Item 5(b) - A handfed circular ripsaw was not furnished with a spreader to prevent

material from squeezing the saw or being thrown back on the operator (1910.213(c)(2)).

Citation 1 - Item 5(c) - A handfed ripsaw(s) did not have non kickback fingers or dogs so located as to oppose the thrust or tendency of the saw to pick up the material or to throw it back toward the operator (1910.213(c)(3)).

SERIOUS - Citation 1 - Item 6 - Feed rolls of a horizontal edge sander were not protected with semi-cylindrical guards to prevent the hands of the operator from coming in contact with the in running rolls (1910.213(p)(1)).

<u>SERIOUS</u> – Citation 1 - Item 7 – A drive belt for the exhaust fan of a spray room was not covered where it entered the ducting of the fan (1910.219(d)(1)).

<u>SERIOUS</u> - Citation 1 - Item 8 - The motor capacitor was broken and improperly repaired, exposing live parts to employee contact (1910.303)(b)(1)).
